## **January Program:**

"A Celebration of the Nineteenth Amendment: Winning the Vote"

**Presenters: Mary Jo Cooney and Leslie Curley** 

Mary Jo will present some of the very interesting and lesser known aspects of the history of the 19<sup>th</sup> Amendment. Leslie will discuss some of the notable impacts of the Amendment, as well as some of the current outstanding legal issues relating to its ongoing evolution. Mary Jo received a bachelor's degree from Hunter College, a master's degree from Columbia University and her J.D. from Catholic University of America. She was admitted to the District of Columbia and Maryland bars. Her work was mainly in the administrative and regulatory spheres. Leslie received her degrees from the College of New Jersey and Suffolk University Law School. She is admitted to practice in Massachusetts.

# "Amicus Personae" – James Case Board Member of The Association of Retired Attorneys of Sarasota

Jim Case grew up in Chicopee, a small industrial city in western Massachusetts where he attended public schools. He graduated from Clark University in Worcester in 1968 with a degree in psychology and a plan to become a lawyer. His plans were interrupted by a two-year stint in the Army at Fort Polk, Louisiana. At the hospital, he managed the Physical Therapy Clinic, which was very busy treating patients, most of whom had been wounded in combat in Viet Nam. That work was very challenging because of the heavy patient load and the severity of the trauma patients had sustained. The work was also rewarding because the intense care the clinic was able to provide made a real difference in the recovery process. Jim was able to leverage limited staff resources but encouraged recovering patients to stay in the clinic after their own therapy sessions and help to encourage and monitor new intakes.

After the Army, Jim returned home, married his college girlfriend, and enrolled in law school at the University of Maine in Portland. Upon completion of law school, Jim successfully took the bar exam and went to work for Maine's senior senator, Edmund Muskie. Jim supported Senator Muskie's legislative activities across a full spectrum of policy areas, working with an extensive staff on the Senate Budget Committee which Senator Muskie chaired, and the Subcommittee on Environmental Protection, which the Senator also chaired and wrote landmark legislation in the area of clean water and clean air.

Jim was serving as legislative director and counsel when Senator Muskie left the Senate to become Secretary of State in 1980. Jim continued working in the Senate serving as Administrative Assistant to Senator Muskie's replacement, George Mitchell. After a year with Senator Mitchell, Jim decided that time was running out for him to enter private practice, so he returned to Maine and joined a firm in Brunswick with a statewide practice representing labor unions and the Maine AFL-CIO. The work varied from individual clients with a range of concerns from a disability claim under the longshore and Harbor Workers Compensation Act, or state workers compensation act, or a disciplinary grievance to large multi-million-dollar arbitration cases. Jim represented unions before the US Department of Labor and the National Labor Relations Board and served as counsel to the Maine AFL-CIO, the Maine Building Trades Council, the Machinists union at Bath Iron Works on a continuing basis and many other unions on a case by case basis. Jim appeared regularly before the Maine legislature on behalf of the Maine AFL-CIO and other unions. During this period, major bitter strikes occurred in Maine in the paper and shipbuilding industries, and Jim and his firm were called upon extensively for representation on numerous issues involved in the strikes.

Over time, Jim's practice expanded to include cases involving discriminatory actions under federal and state law. Cases based on disability, gender and age became an increasing focus on the firm during the last years of Jim's 30-year practice and came to be nationwide in scope. Individual discrimination claims were the most common, but broader collective actions were exciting and challenging. Jim enjoyed all of the elements of his professional career and feels fortunate to have had the opportunities to contribute that life presented to him.
